Russell Bedford strengthens year-on-year, supporting the network's strategy to do better business globally, equipping and empowering our people so that they, and their clients, go further to a better future.

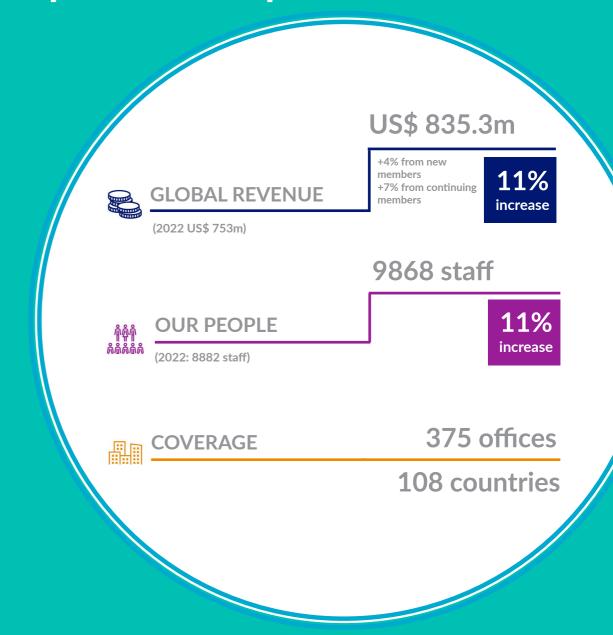

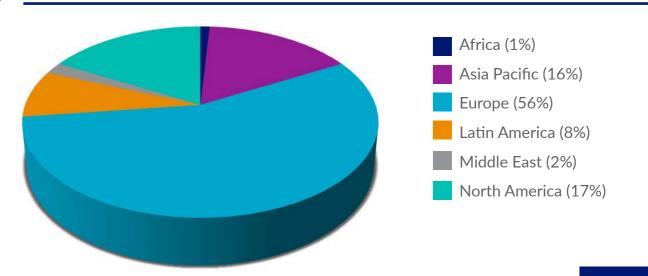

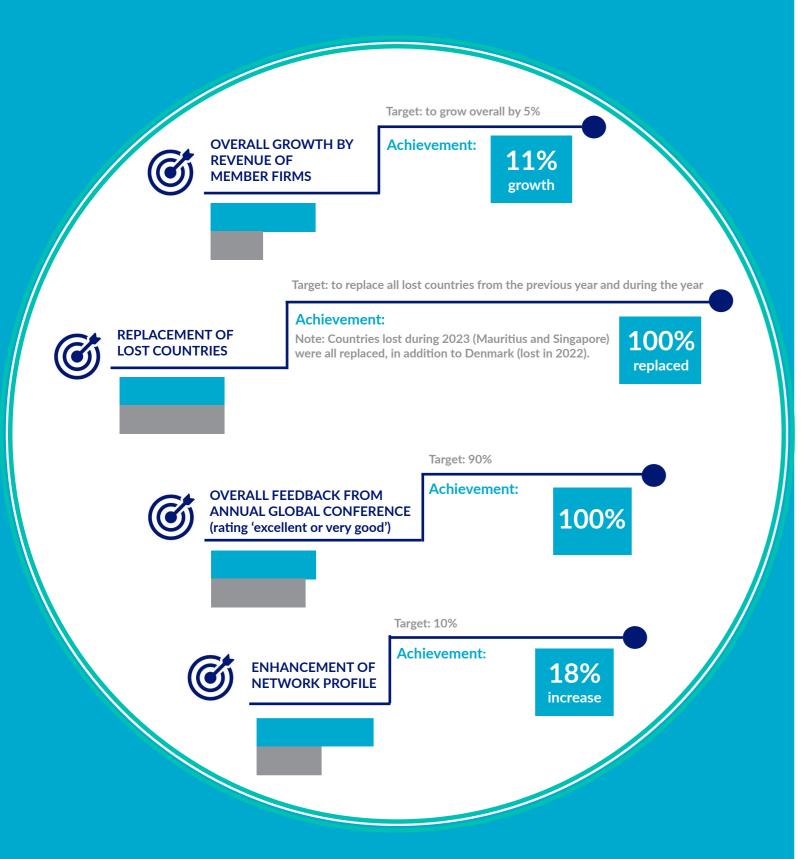
FEE SPLIT PER SERVICE LINE

Russell Bedford Cares...
